



## Member Jurisdictions International Fuel Tax Agreement (IFTA)

New York State has participated as a member of IFTA since January 1, 1996. Under IFTA, a motor carrier reports all the fuel taxes that it owes to the various IFTA jurisdictions to a single base jurisdiction. Most of your questions should be directed to New York State, your base jurisdiction. However, questions about exemptions that might be allowed in another jurisdiction, for example, should be directed to that particular jurisdiction.
